LEVELS: USDF Introductory - FEI Grand Prix, current editions.

AWARDS: Trophy (in classes of 3 or more) and six ribbons (each division pinned separately)

Class 152 on Sunday is USDF/Dover Medal Class.

An American Trakehner Association High Point Ribbon will be presented at finish of show on Sunday.. *Proof of eligibility must accompany entry.*

NOTES:

NEW LEVELS THIS YEAR: Opportunity Training Level Tests 1 & 2, Opportunity 1st Level Tests 1 & 2, Opportunity 2nd Level Tests 1 & 2. These classes do NOT require membership, non-member fees, Drugs & Med tests and the Federation Fee for horse or rider. Results are not reported on USDF/USEF post-competition reports and do not count towards USDF/USEF awards or programs.. Riders and horses MAY cross-enter into other classes that will follow all USDF/USEF normal class requirements. Please see USEF Rules GR821.3 & .4 GR821.2e(5).

*** PRIZE MONEY:**

Class 40, Saturday. Award to Adult Amateur, 50 yrs or older of \$100. Can not have competed on this horse at a higher level. Award given at Sat. Competitor dinner. Sponsor : Topperhill Farm.

\$75.00 to High Point in Intro - Training Level ; \$75.00 to High Point in 1st Level - Third Level;

\$75.00 to High Point in 4th Level - Grand Prix. Sponsor for 3 High Point Awards: Crossroads Dressage Society. Must be member of Crossroads Dressage Society.

*****Team Challenge:** Top three teams split the “Pot” of entry fees (50%,30%,20%). \$5 entry. Team Entry Form and Rules in office at check-in. **Sign up is Friday in office!!!** Secretary’s office will be open at 12 noon.

FEES:

USEF FEES: Qualifying fee \$10 per class, Fee per horse -\$8, (D+M-\$7) = \$15, Non-member fee \$30 per rider, owner, trainer.

USDF FEES: Non-member fee-\$20, Affidavit fee-\$5.

SHOW FEES: OFFICE FEE-\$25. CHANGE CLASS FEE-\$10. POST ENTRY FEE (after June 3) -\$10/class. GUEST HORSE FEES (non-competing): \$25 Office Fee, plus Grounds or Stall Fee. STALL FEES: \$50 per day, \$90 per weekend; Tack Stall: \$30 per day, \$60 per weekend.

GROUNDINGS FEE: \$15 per horse/day for non-stabled horses. **BAGGED SHAVINGS:** \$7/bag delivered. **RV/CAMPER FEE:** \$25/night, no camper hookups allowed in barn area. **REFUNDS:**

Before closing date: full refund less \$25 office fee; after closing date or after the start of the competition: no refund. NO refund for cancellation due to acts of God. **BOUNCED CHECK FEE:** \$35 charge, entry voided. Placed on waiting list until money order, certified check, or cash is received.

ENTRIES: Checks drawn to “Dressage by the River”. Mail to Secretary Tina Henderson. Copies of USEF membership cards (or nonmember fees) for rider, owner, trainer, & horse id#, (and coach if applicable), copies of USDF rider, owner, membership cards or nonmember id, & horse id#, must be included. *Introductory and Opportunity classes exempt from USDF/USEF memberships.* Include copy of current (within 1 yr.) negative Coggins. Tennessee State law requires the original copy of Coggins be presented to secretary at check-in. State “Qualifying” if applicable and include copy of USEF, USDF horse registrations. Specify test in TOC classes.

Freestyle entrants must submit copy of 60%+ ride in the highest test of the level. **Include copies of all appropriate USEF/USDF memberships and certificates. All riders/owners/trainers must have USEF/USDF membership or pay non-member fees.** (see www.usef.org and www.usdf.org). Introductory Class entries exempt from USEF/USDF memberships. Entries first come first served basis. **Post entries** will be placed on waiting list if entries warrant. **Guest Horses** must submit entry, current Coggins, all fees with exception of class fees.

START TIMES: Official times available Friday before show at the secretary's office 865/475-1005. Secretary's office will open at 12 noon. Unofficial ride times posted on www.river-glen.com Wednesday prior to the show. Stabling charts also posted on the web site.

STABLING: 210 Permanent stalls with stall gates in shed row barns. Stallion stalls available. Bagged shavings available. May pre-order and pay on entry. Competitors wishing to be stabled together please list ONE name to coordinate the group. **For the fourth year!!!!...all groups of 5 will qualify for a free tack stall. Groups MUST stable together and send entries together, or make sure group name is listed on entry.**

ARENAS: Three full sized Dressage Arenas, two 180' x 300'. Warm-up arenas, lunging arena. Unlimited grass areas for hacking and grazing. Excellent all-weather footing is crushed limestone and river sand.

HOSPITALITY: Food available on the grounds. Early morning coffee and snacks will be served in the barn area for early riders, provided by CDCTS (Crossroads Dressage and Combined Training Society). Complimentary Wine/Cheese reception Friday evening. Complimentary competitors dinner Saturday. Dinner tickets \$10 to non-competitors.

ACCOMODATIONS: Double Host Hotels: Ramada Inn 865/546-7271 and Comfort Suites 865/246-2426 (both at exit 398). All local hotels listed on www.river-glen.com approx 20 min away.

DIRECTIONS: DO NOT USE MAPQUEST!!!!

From Knoxville and West (I-40): Exit 394, Turn left at light onto 11E. Travel East approx 16 mi to RG sign (on left side of Hwy) at Lowery Loop Rd (across from New Market Church). Turn left at sign, go straight through stop sign and turn left at Baker Rd. (1st left). You will see signs directing you all the way to River Glen from this point at each necessary turn.

Note: Do not veer off to right on 11E where it forks and says 11W/25W. Stay to left.

From Dandridge and East (I-40): Exit 417. Go right at light onto Hwy 92. Travel approx 10 mi to 11E. Go West or left approx 6 mi to River Glen sign on right of Hwy at Lowery Loop. Follow directions above.
